Dear Fellow Radio Amateur:

One aspect of amateur radio is its ability to serve the public, especially through emergency communications. YARA recognizes this fact with its commitment to the community and its partners with several formal MOUs and agreements in place with disaster and emergency-oriented civil and government agencies. Amateur Radio truly is a vital community resource.

The YARA Emergency Radio Communications Plan, along with ARES manuals and other resources referenced on the YARA website is a phase of the YARA commitment to excellence in modern emergency communications support. It will help Yukon amateur radio operators to acquire, develop and refine the skills needed to perform at a high standard in an emergency communications situation.

All YARA executive, directors, and licenced operators now have the opportunity, but are not required, to successfully pass the certification examination that follows.

Others with an interest in being part of this community resource may also write the exam and become YARA Certified Radio Emergency Communicators, regardless of whether they are current active YARA members. YARA membership, while greatly encouraged, is not a requirement.

Candidates who successfully complete YARA Certified Radio Emergency Communicators Exam will receive a wallet identification card, a certificate, a YARA Certified Radio Emergency Communicators Radio Vest, and have their names posted on the YARA website.

The examination is "open book" and this is no time limit. That is, the candidate is encouraged to refer to the reference materials while writing the exam. It covers a lot of material and may take several hours, and perhaps more than one sitting to complete if you have not previously covered the material. The source documents for successful completion of the examination are available on the YARA website for viewing or for download and from the website links listed on the YARA website.

Successful candidates will be listed as a YARA Certified Radio Emergency Communicator (CREC) on the YARA website and will receive a certificate, wallet CREC ID, a YARA CREC communications vest. The completed exam will NOT be returned to you, nor will you be advised of your mark - only that you passed or failed. In the latter case, you may re-write immediately. Allow a reasonable time for processing.
